**Length of season:** 33 weeks -- September 12, 2011 – April 30, 2012

**Method of Billing:**

1. \$100 deposit per court hour at time application is submitted.
2. If Year Round Membership is not already paid, all Winter Tennis Membership Fees + balance of Contract Court Time fees will be collected in two payment installments. First half of contract court time due by June 30<sup>th</sup>, remainder due by August 15th. **Late Fees will be applied to any invoices not paid by due date.**
3. All deposits are non-refundable unless the time requested is not available.

2. Each application form must be accompanied by a check for the deposit. **Checks should be made payable to West Winds Tennis & Fitness Center** and should reflect the applicant's name, home address, and home telephone number.
  3. Court time applications will be accepted on both the hour and the half hour. Time slots will be given for one hour, one hour and one-half, or two hour periods.
